

# Privacy statement MareVisie BV

**MareVisie respects your privacy and handles your personal data with care.**

This privacy statement applies to the processing of personal data by MareVisie of customers visitors to its (mobile) websites and recipients of its (online) mailings and social media messages. The information MareVisie obtains about you is processed with the greatest possible care. MareVisie processes personal data first and foremost in connection with its services to customers. In doing so, MareVisie abides by all applicable laws and regulations, including the General Data Protection (Regulation (EU) 2016/679) (AVG). ## Purpose of and legal basis for processing

MareVisie processes personal data primarily in the context of its services. Through MareVisie's websites and online mailings and social media, personal data are processed. The Website offers in a number of places the opportunity to respond, for example by signing up for the newsletter, requesting information or registering for an event. If you respond, MareVisie will of course process some of the data that you provide and that is necessary to answer your request. MareVisie will process your data for marketing and communication purposes to inform you about relevant products and services through the website and online mailings. Your data may also be used to inform you about interesting news and events through the websites and online mailings.

MareVisie also processes personal data in the course of its business operations, including:

- recruiting and selecting personnel
- administration;
- access to ICT systems;
- archiving and dealing with requests, complaints and disputes.

Your data will not be processed for purposes other than those mentioned above without your consent. Legal bases for the processing are entering into and executing agreements that MareVisie concludes with you, complying with legal obligations and promoting MareVisie's legitimate interests. If necessary, you will be asked for permission for the processing of personal data.

## Which personal data does MareVisie process and what is the origin of this data?

Personal data that MareVisie processes may include your name and address details, your gender, your e-mail address, your telephone number, your job title and possibly other data that are necessary in the context of our services or other processing purposes mentioned.

## Who do we share your data with?

In principle, MareVisie does not share your personal data with third parties, unless they act on behalf of MareVisie and this has been determined in accordance with AVG.

## Retention of your personal data

Your personal data will not be stored by MareVisie longer than necessary for the purpose for which they were collected, for the performance of legal tasks and the fulfillment of legal obligations or the performance of agreements (such as limitation periods). MareVisie adheres to the legal retention periods.

## Security of your personal data

MareVisie takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized changes. ## Your rights with regard to personal data processed by MareVisie

When your personal data is processed by MareVisie, you can exercise the rights below on the basis of the GDPR. You can do this by submitting a (preferably written) request to [info@marevisie.nl](mailto:info@marevisie.nl). Before we grant your application, we must first identify you by means of a valid proof of identity.

### *Right of access by the data subject*

You can always request which personal data MareVisie processes, for what purpose this is and for how long it will be stored. There may be a legal basis that prevents MareVisie from responding to your request, we will assess this and inform you about this.

### *Right to rectification*

If you believe that certain data has not been processed correctly, you have the right to request rectification of this data.

### *Right to be forgotten (erasure of your data)*

If you want your personal data to be deleted, you can submit a request for this.

### *Right to restriction of processing*

If you want to limit the processing of personal data by MareVisie (pending the rectification of your personal data requested by you, objection to processing or because you do not want data to be deleted despite the processing being unlawful), you can submit a request for this.

### *Right to data portability*

If you want to transfer your personal data to another service provider, you can submit a request for this.

### *Right to unsubscribe updates and direct marketing*

If MareVisie uses your data for disclosing information or direct marketing, you can unsubscribe at any time so that you do not receive any information from us.

### *Possible restrictions on exercising your rights based on the General Data Protection Regulation*

MareVisie makes every effort to comply with your rights based on the GDPR. However, these rights may conflict with other legal provisions. If for that reason one of the aforementioned requests cannot be met, you will be informed in writing.

### *Complaints about the processing of your personal data by MareVisie*
